

West Lakeview Neighbors Meeting July 13, 2015; 7:00pm; Mystic Celt; 75 people present

Tom Kelley, Treasurer, called the meeting to order at 7:07pm.

WLVN membership requirements were reviewed.

There will be no vote taken tonight on the WF project. A meeting will be held August 10th for a vote.

Novak Construction, John Novak/Whole Foods update: with Power Point presentation.

A cafe will be on the 1st floor. Live wall to Melrose St. Park space has been added to the Melrose side, Gale and Bryan made the PP presentation:

Activate Ashland retail: there will be an 83% retail frontage, up from 37%, with transparent windows and a 12' wide cafe.

Melrose facade: smaller scale materials, sidewalk setback, windows are translucent.

Green space on Melrose to the east of the entrance will be 25 wide x150' long. Sidewalk becomes a winding trail type walkway, for the 6 bldgs across the street the view will be green space. The ground floor will have a green wall with plantings that will stay vibrant throughout the year.

Question: when will the traffic study be available to review? Why are only 3 times of the day identified?

Answer: the times are selected to capture the highest traffic patterns for those intersections.

Question: the numbers for each block don't make sense

Answer: there are cars turning and store parking. The light will be 85 - 105 seconds

Question: the light doesn't jive with the bank of America across the street

Answer: the intent is not to signalize it

Question: the changes are good, in the traffic study what happened to the one way for Melrose and culdu-sac possibility?

Answer: Plan is to make Melrose one way up to the alley, then 2 way from there to Ashland

Question: study doesn't show cars coming in and out of stores. We're trying to get an idea as to traffic

Answer: the Melrose exit will see more traffic, there will be 2 outbound lanes.

Lee Crandell commented that the Chamber of Commerce is in favor of the project.

Chris Sotos stated that the store will be the anchor to the neighborhood.

Question: why isn't the cul-du-sac possible? There may be a lot of traffic going through the alley. How to optimize problem with cars turning into the parking bldg and there are only 47 parking spaces there.

Answer: CDOT did look at the cul-du-sac possibility and would not agree to it because of safety issues.

CDOT has approved the plan. : The new store would have better parking, and the light will solve jams.

General comment: The WF on School has a difficult entrance from Ashland.

Question: what will happen to that store? Answer: there is no info on what might go in

Questio: Are mechanicals close to that wall on Melrose?

Answer: No.

Question: Won't a bus cause the Belmont entrance to back up?

Answer: There will be parking spaces removed.

Question: Can you show it?

Answer: It's on the Alderman's website

General comment: Thank you for working with the neighborhood.

Question: if the traffic is not changed to flow into WF will the project be cancelled?

Answer: they feel the safest plan has been decided

Question: On the traffic study there is no difference in number for Greenview, will there be no traffic?

Answer: about 5% are assumed to be driving on Melrose

Question: why are there more parking spaces than necessary for the city's requirement?

Answer: adequate parking in peak hours is the concern. WF feels that number of spaces is absolutely

necessary for this location

General comment: This is one of the best grocery store plans. We should take a vote tonight so the store

can begin construction.

Question: what is the average occupancy in the parking bldg on Kingsbury? Answer: during holidays it's full, about 90% of the time over weekends

Question: what security will there be after hours?

Answer: electronic gates
